







DDNS 주소를 확인하려면

카메라가 DHCP 방식의 케이블 모뎀이나 DSL 모뎀 혹은 PPPoE 모뎀에 직접 연결되어 있는 경우, ISP(사용자가 기입한 통신회사 서버)에 연결을 시도할 때마다 IP 주소가 변경됩니다. 이 경우 사용자는 변경된 IP 주소를 알수 없습니다.

웹뷰어는 기존의 플러그인 웹뷰어와 새로운 플러그인 프리 웹뷰어가 함께 내장되어 있습니다. 이로 인하여 Chrome, EDGE, FireFox(Windows 64bit only) 등 플러그인을 지원하지 않는 최신 브라우저 환경에서도 웹뷰어 사용이 가능합니다. 플러그인이 설치 가능한 IE, Safari 브라우저에서는 플러그인 설치를 권장합니다. 브라우저 환경에 따라 다음과 같이 차이가 발생합니다.

- Chrome, FireFox(Windows 64bit only), EDGE, Safari 브라우저 : 플러그인을 사용 할 수 없는 브라우저 환경이지만 플러그인 프리 웹뷰어가 탄재되어 웹뷰어 사용이 가능합니다.


